



FSC Paulownia Wood Surfboard Kits & Supplies

For a lightweight, high-performance board consider using Paulownia lumber. Paulownia is about 2/3 the weight of lightest commercial wood grown in Heze city Shandong province China.

It's weight is about 290-310kgs/m<sup>3</sup>. Yet paulownia has great strength and is nearly knot-free. It is light-blond in appearance and will take stain well, allow you to create a custom look for your board.

We also have FSC paulownia board certification.

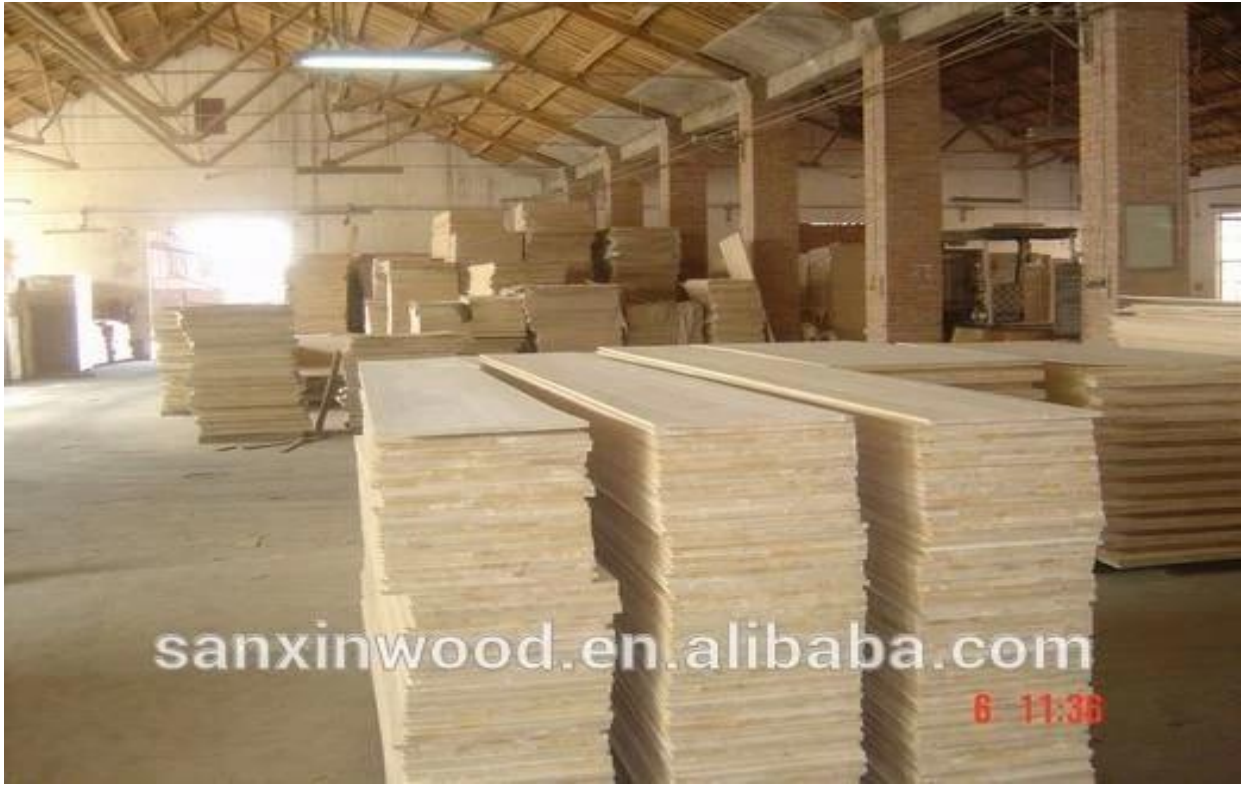

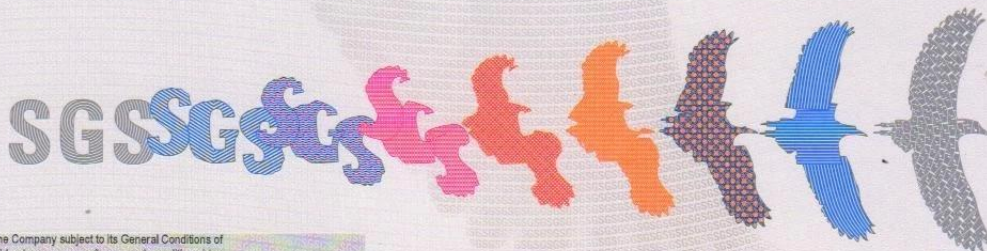
